The Customer accepts the following obligations:

- §1 The customer will pay the fees in a timely manner according to the schedule agreed on the front of this sheet.
- §2 The customer will provide free access for the Klin Salone local service provider for the purpose of emptying the waste container, and will ensure that the container is placed in such a way that it can easily be emptied.
- §3 The customer will ensure that all the waste is placed inside the container and will keep the container and its surroundings clean.
- §4 The customer will protect the container from theft and damage, including fire damage.
- §5 The customer will ensure that non of the following items are placed in the container:
 - a. Toxic or hazardous chemicals or substances
 - b. Any type of explosive or flammable substance
 - c. Dead animals
- §6 The customer will inform the Klin Salone local service provider in advance if the customer wishes to cancel the services.
- §7 The customer has the right to inform Klin Salone Waste Management Association in case of any grievances with respect to the service provision.

The Klin Salone local service provider accepts the following obligations:

- §1 The Klin Salone local service provider will provide and deliver to the customer the garbage container as agreed to in this contract.
- §2 The Klin Salone local service provider will empty your garbage container according to the schedule agreed to in this contract.
- §3 The Klin Salone local service provider will make every effort to inform the customer in advance of any interruption of services. In case of any unforeseen interruption of services, the Klin Salone local service provider will inform you within 14 days and deduct the missed collections from your weekly or monthly payment.
- §4 The Klin Salone local service provider and Klin Salone Waste Management Association do not take the responsibility for any interruption of services due to any unordinary natural catastrophe (including, but not limited to: flood, heavy thunderstorm, or fires) or violence or political instability (including, but not limited to: riots, insurrections, and governmental or military operations).
